




Jewish Museum in Prague 2023 Annual Report

In 2023, the Jewish Museum in Prague (JMP) received 552,938 visitors, which is 145,024 more than in 2022, but 124,561 fewer than in the pre-pandemic year of 2019 – a decrease of 18.4% in comparison with that year. In response to the arrival of Ukrainian refugees in the Czech Republic, the JMP (in cooperation with the Jewish Community of Prague) provided Ukrainian asylum seekers with free access to its exhibitions. As in previous years, the JMP continued to provide considerable discounts for visiting school groups through its Education and Culture Department. There was ongoing public interest in the tours of Prague's Jewish Town that are held in connection with the JMP's educational programme

Visitor numbers and visitor services against antisemitism (on Sundays and public holidays at 11 a.m. and 2 p.m). The activities of the JMP's Society of Friends also helped to successfully promote the Museum.

The tourist discount cards Prague CoolPass (formerly the Prague Card), Prague Visitor Pass, Prague City Pass, and the Lítačka Card attracted a total of 28,680 visitors to the JMP.

Finances

The year 2023 marked a return to normal operations for the JMP after three years of financial crisis. With increasing visitor numbers, the JMP was able to start reviewing its investment plans and recruiting new staff for positions left vacant in the wake of the difficult financial situation caused by the Covid-19 pandemic. Work also began on the JMP's strategic sustainable development plan for 2024–2028, as well as setting out strategic financial targets.

In 2023, the JMP's revenues totalled CZK 221,462,096, which is an increase of 49.23% compared to the previous year, when its revenues amounted to CZK 148,403,188. The main reason for this growth was the rise in visitor numbers, which reached 78.74% of the levels from the pre-Covid years 2017–2019. Compared to 2022, visitor numbers increased by 35.55%. Ticket sales in 2023 totalled CZK 180,259,385, compared to CZK 115,964,370 in 2022, which is a year-on-year increase of 55.44%. In 2023, there was a 14% increase in ticket prices.

The JMP's costs in 2023 amounted to CZK 190,148,067, which represents a year-on-year increase of CZK 48,425,282 (up 34.17%). Specifically, these increases related to material expenses, goods sold, donations, wages, social security contributions, and other costs.

The JMP's financial results for 2023 ended in positive figures. It recorded a gross profit of CZK 38,317,059 (after paying tax of CZK 7,003,030) and a net profit of CZK 31,314,029.
